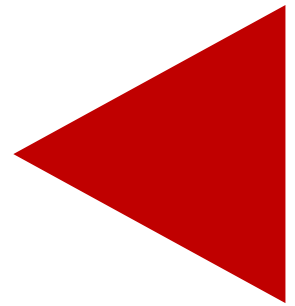


YMCA Refer a Friend April School Holidays Competition

By entering this competition conducted by YMCA Auckland, entrants agree to have read, understood and accepted the following Terms and Conditions.

1. To enter the competition all entrants must complete and submit their entry form by 10/05/2019. Entries received after the closing date will not be accepted.
2. Prizes are not redeemable for cash, are not transferrable to any other person, and can not be used in conjunction with any other offer or promotion.
3. This competition is set around a referral basis. Entrants must nominate someone they know to go in the draw to win. To be eligible to enter, both parties must enrol their child(ren) in YMCA Auckland, Hamilton or Tauranga April School Holiday programmes (see www.ymcauckland.org.nz/aprilmholidays for full programme listings). The main prize winner will be the Main Winner (referrer) and the referred party will be the Sub Winner (referee).
4. The referrer accepts any responsibility for providing third party contact details, and in entering this competition, the referrer deems they have permission to share the referee contact details with YMCA Auckland.
5. There will be three prize categories for this competition; Auckland, Hamilton and Tauranga. If the competition prize becomes unavailable (for any reason), YMCA Auckland reserves the right to provide the winner with a substitute prize. The prize details are as follows;
 - a. Auckland
 - i. Main Winner (referrer) will receive; one term of Kid's Recreation or Sports of their choice, one term of swimming lessons (any age), three month's fitness membership for two adults and a YMCA merchandise family pack.
 - ii. Sub Winner (referee) will receive; three month's fitness membership for two adults.
 - b. Hamilton
 - i. Main Winner (referrer) will receive; one term of Kid's Recreation or Sports of their choice, three month's fitness membership for two adults and a YMCA merchandise family pack.
 - ii. Sub Winner (referee) will receive; three month's fitness membership for two adults.
 - c. Tauranga
 - i. Main Winner (referrer) will receive; one week of After School Care for free and a YMCA merchandise family pack.
 - ii. Sub Winner (referee) will receive; a YMCA merchandise family pack.
6. Prize draws/selections will be made, at random, on 15/05/2019. All winners will be contacted as per the contact details provided on the entry forms.
 - a. If the Main Winner (referrer) does not acknowledge receipt, cannot be contacted and/or is not available in person to accept the prize within the advertised timeframe, the draw/selection is cancelled and another draw made. This will also deem the Sub Winner (referee) entry void.
 - b. By accepting the prize, the winner consents to YMCA Auckland using the winner's details, photographs and other material for reasonable promotional purposes including but not limited to website notices, posters, emails, online marketing activity and press.
7. The following persons may not enter the competition and are not eligible to win any prize:

- a. The information provided on the entry form will only be used to contact the winners and for promotional purposes and marketing communications. Entrants can opt-out of our communications database at any time.
 - b. All entrants consent to that, if they win a prize, YMCA Auckland may use their name and photograph for publicity purposes which could include print and internet articles and social media postings.
 - c. All information provided by the entrants will be collected, used, stored, disclosed and corrected in accordance with the Privacy Act 1993. All entrants have the right to access their information and request for any personal information to be corrected.
